#### Important Notices

- All intermediate games will be 4 x 10 minute with 2 minutes quarter time and 3 minutes half time.
- There is no injury time (however the game can be stopped to allow injured player to be taken from the court in the instance of a serious injury).
- Team cards must be FILLED IN BY THE END OF THE THIRD QUARTER of the previous round or 10 minutes before the start of play for those in the first round. Pre-printed labels are accepted, but they must fit in the space allocated on team card.
- If a player is named on the score card they are recorded as playing that game
- Day Registrations must be completed same time as completing score card with all player details.
- No Jewellery is to be worn **except** a medic alert bracelet which must be taped.
- Adornments worn for cultural or religious reasons should be taped securely to the body and if possible covered by a sweatband (e.g. to cover a Kara bracelet) in order to ensure the safety of the applicant/participant and those participating in the associated competition.
- No earrings or studs are to be worn even if they are taped.
- Fingernails must be short and smooth
- Please make sure all players are in their registered uniform

#### Team benches and Scorers for all games and grades

- All teams (players, officials, scorers and timers) must be on the side of the court facing the netball pavilion
- One player from each team is to stand side by side & record score on score card
- No one is to stand at the end of court behind the goal post – out of bounds
